Doors will open at 7:30 am. Start time/Play begins at 8:30 AM. There will be a coaches / referee meeting at 8:00 AM and warm-up will start at 8:10 AM.

Admission: \$5 for adults, \$4 for children, Free for under 3.

Concessions: There will be concessions at this tournament. You are welcome to bring team/individual coolers, but, know that nutritional options are available. Please keep food and coolers out of the Fieldhouse. There will be a 30 minute break prior to bracket play.

Warm-ups: Please bring volleyballs to warm up with, game balls will be provided. Warm ups will be 2-4-4, subsequent warm ups in pool play will be 4-4 unless the coaches want to begin play.

Format: Pool play will be 2 sets to 25 (27 cap), NO third game. Tie breakers will be determined by matches, set, and point differential followed by a coin toss if all else are tied. After pool play, the top eight teams will move to the gold bracket, the second three teams will be in the Silver bracket, next three in bronze, last 3 in copper. Matches in bracket pool are two sets to 25 (27 cap) with the third set to 15 (17 cap) if needed, finals to be two sets to 25 (no cap) with the third set to 15 (no cap) if needed.
